
**WHEREAS**, the Murrells Inlet-Garden City Fire District Board of Directors has determined that these fees shall be updated annually as part of the budget process.



## Amendment

Multi-family residential occupancies will not be charged a fee for the initial annual inspection or for the 1<sup>st</sup> subsequent re-inspection (if needed) but will be subject to a \$100 re-inspection fee for each additional re-inspection required.
